***COURT GRANTS MOTION TO INTERVENE ALLOWING NYS  
TENANTS TO JOIN BASELESS LAWSUIT ATTACKING  
RECENTLY PASSED HISTORIC HOUSING REFORMS AND  
LONG STANDING RENT STABILIZATION PROTECTIONS***

(NEW YORK, NY) – **The Legal Aid Society, Selendy & Gay PLLC, and Legal Services NYC** lauded a court ruling today by the United States District – Eastern District of New York granting a motion to intervene on behalf of N.Y. Tenants and Neighbors (T&N), Community Voices Heard (CVH), and the Coalition for the Homeless (the Coalition) on *Community Housing Improvement Program, et al, City of New York* – litigation recently brought to dismantle the historic statewide housing reforms enacted into law this past June and New York’s long standing rent stabilization laws that have existed since 1968.

**Justice in Every Borough.**

The motion argued that Petitioners have standing and the right to intervene on behalf of T&N, CVH, and the Coalition as these organizations represent thousands of members who are rent stabilized tenants and who stand to lose their homes, as well as homeless people who will not be able to find housing if Plaintiffs in the aforementioned lawsuit succeed. The Court also granted Petitioners' leave to file a motion to dismiss.

“The court made the right decision allowing New York’s tenants and homeless people to have voice in this litigation to safeguard the historic housing reforms enacted in June and the protections afforded by our long-standing rent laws system,” said **Judith Goldiner, Attorney-In-Charge of the Civil Law Reform Unit at The Legal Aid Society**. “We look forward to swiftly defeating this lawsuit for our clients and other renters throughout the state.”

“We are pleased with the court’s decision to allow tenant groups to intervene in this frivolous lawsuit attacking critical New York City rent protections,” said **Ed Josephson, Director of Litigation and Housing at Legal Services NYC**. “These rent reforms were put in place for a reason – to protect New York City families’ access to safe and affordable housing in a city where more and more people are being priced out. We look forward to bringing this lawsuit to an end very soon.”
