The Legal Aid Society's 44th Annual Servant of Justice Awards Celebrated the Resilience of Staff and BIPOC Communities During a Year of Enormous Challenge

Event Honored Roger W. Ferguson, Jr. - Former President and CEO of TIAA, with Special Guests Wes Moore, Ali Velshi and Performances by Daniel Yearwood & Johanna Moise

(NEW YORK, NY) – The Legal Aid Society held its 44th Annual Servant of Justice awards last Thursday, celebrating the work of the organization's staff representing New York's most vulnerable communities on a myriad of issues throughout the COVID-19 pandemic.

In the past year, the staff of The Legal Aid Society has served as legal "frontline responders", advocating and litigating for low-income communities during a year where COVID-19, police violence and racialized unrest devastated so many.

While these issues have plagued BIPOC communities long before COVID-19, the increased disparity in healthcare, access to needed resources and the isolation of incarceration in jails and prison was life-threatening. Every single day, Legal Aid leads the fight in protecting incarcerated clients in jails, prisons and ICE facilities from COVID-19 exposure; ensuring that families living in shelters have working internet to access remote learning; securing critical protections for

tenants defending against eviction and homelessness; and advancing key juvenile justice issues to benefit young clients.

In addition to celebrating the work of staff, the event honored Roger W. Ferguson, Jr., former President and CEO of The Teachers Insurance and Annuity Association of America-College Retirement Equities Fund and former Vice Chairman of the Board of Governors for the Federal Reserve System, where he led the Fed's initial response to the 9/11 terrorist attacks.

Ali Velshi, host of "Velshi" on MSNBC served as emcee of the evening's program.

Additional speakers included members Jarrett Payne, a community activist and the lead Plaintiff in a <u>lawsuit</u> brought by Legal Aid and NYCLU last fall to hold the NYPD accountable for its violent handling of the George Floyd demonstrations; and Wes Moore, CEO of the Robin Hood Foundation - one of the largest anti-poverty organizations in the nation.

To close out the event, Yusef Salaam of the Exonerated Five spoke, and Daniel Yearwood and Johanna Moise, Broadway actors from plays including Hamilton, The Heights and Wicked, performed a mashup of various songs from those shows.

"We've worked to keep families in their homes, freed clients from deplorable jail conditions, and ensured that our young clients in congregate settings have unfettered access to the COVID-19 vaccine. To say the least, the last year has been trying but it has also revealed the indefatigable resilience of both our staff and the New Yorkers we serve."
