Legal Aid Celebrates 46th Annual Servant of Justice Awards Over \$3.2 Million Raised to Support Client Advocacy Efforts

(NEW YORK, NY) - The Legal Aid Society held its 46th Annual Servant of Justice Awards Dinner on Thursday May 11th, at Cipriani 42nd Street. The annual celebration was attended by over 700 guests, representing New York City's business and legal communities, and raised over \$3.2 million. Support from the event funds critical legal services programs that assist New Yorkers in the areas of education, housing and homelessness, immigration, family law and domestic violence among many others.

Mayor Eric Adams commemorated the event, sharing a <u>letter</u> lauding The Legal Aid Society's central role in "maintaining a system of justice that promotes equality and progress."

Every year, The Legal Aid Society recognizes pro bono partners who have gone above and beyond to support its work and client communities. The 2023 Servant of Justice Awards honored the AIG Pro Bono Program, accepted by Lucy Fato, Executive Vice President, General Counsel & Global Head of Communications and Government Affairs at AIG; Richard R. Buery, Jr., Chief Executive Officer at Robin Hood; and Mark P. Goodman, Partner, Co-Chair of the Commercial Litigation Group at Debevoise & Plimpton.

<u>Jason Flom</u>, Founder & CEO of Lava Media and Lava for Good Podcasts, and <u>Paul S. Bird</u>, Partner, Head of European Corporate Practice at Debevoise & Plimpton LLP, shared a special introduction to the honorees.
