## **Ehen fa na me nko nkope atenaee wo New York Kuropon no mu bere me ye Obi a W'aba Foforo?**

Se wo ye obi a W'aba Foforo na wo hia atenaee bere a edi kan a, esee se wo ko Asoee a Won a w'aba foforo no ko (Arrival Center) wo Roosevelt Hotel, 45 E 45th Street, New York, NY, 10017, a etoa Grand Central Station. Wobue Arrival Center no donhwere 24 da mu no mu nyinaa, nna nsonn nnawotwe no mu, na ebetumi aboa wo ama w'anya atenaee wo New York Kuropon no mu anaa ewo baabi a wo ara ankasa wo pe.

Arrival Center no nso betumi aboa wo wo akwan afoforo bi so, te se, woreye apomuden nsiakyibaa, ayarehwe mmoa, woretwerere wo din de ako sukuu bi mu ne adwene mu apomuden dwumadie ahodo. Ewo Arrival Center ho no, wobehyehye nkrataa bi de atwerere wo din. Se wo mpe se wobonya mmoa biara bere a worefiri New York Kuropon no mu a, enee, yebema wo mpa wo atenaee ahodo mu.

## **Atenaee ahodo ben na wobetumi de ama me atena mu?**

## **HERRC**

HERRC gyina ho ma Humanitarian Emergency Response and Relief Center (Putupuru Mmuuae ne Mmoa Asoe a ode boa Nnipa). Wode saa atenaee ahodoɔ yi som ankorakora ne mmusuakuo. HERRCs ahodoɔ beye du-nsonn na ewo New York Kuropɔn no mu afanan nyinaa. HERRCs a wode ma Mpanimfoɔ a won nko ara nam ne Mpanimfoɔ abusuafoɔ afoforɔ ka won ho no ye dee wɔaka wo ne afoforɔ abɔ mu (ɛkyere se wo ne afoforɔ bekye beaee a wo da no). Mmusuakuo a mmɔfra nkumaa ka won ho da won anka dan ahodoɔ mu anaa adan a wakyekye mu mu. Ahohoɔ nyinaa no, woma aduane wo beae ho (beae a wobenoa woankasa anaa nnipakuo aduane nni ho). Dwumadie ahodoɔ no bi ne nnooma sie, apɔmudenhwe, woretu akotena baabi mmoa, ne nsem asiesie.

## **Respite Centers**

Respite Centers ye atenaee ahodoɔ a wakeka abɔ mu se wode ma se wontena ho mmeretiawa bi. Won a wote ho no betumi ne afoforɔ pii ada dan korɔ mu. Seesei, wɔmfa mmusuakuo a mmɔfra nkumaa ka won ho no nko Respite Centers; wode saa asoe yi som Mpanimfoɔ a won nkoara nam ne Mpanimfoɔ abusua (wɔkyere ase se Mpanimfoɔ mmienu anaa dee eboro saa won ye abusuafoɔ a abɔfra kumaa biara nka won ho). Respite Centers wo beae bebree, a ofise adan dada ahodoɔ a obiara nni mu seesei ka ho, nsore ahodoɔ, sukuu ahodoɔ ne adan afoforɔ a won mfa mma nnipa ntena mu nkye mmerɛ tenten biara. Respite Centers ma ahohoɔ mpa a abɔfra da mu ne kuntu, nnuane, ne adwarebea (adwarebea no betumi aye dee enni beae ho). Ne nyinaa mu no, Respite Centers ma mmoa kumaa bi.

## **DHS Atenaee**

New York Kuropɔn Asoe a Ehwɛ Won a Won Nni Baabi Tee Nhyehyee So New York City Department of Homeless Services ("DHS") no ye atenaee nhyehyee kɛsee. Obi a W'aba Foforo no betumi anya DHS atenaee mmoa bere a Arrival Center a ewo Roosevelt Hotel aka se ese se eye saa. Wobetumi anya baabi wo DHS bere a Arrival Center no ntumi nya baabi papa mma wo wo HERRC anaa Respite Center. DHS wo atenaee nhyehyee soronko ma mmarima mpanimfoɔ a won nko ara nam, mmaa mpanimfoɔ a won nko ara nam, abusua a won ye mpanimfoɔ ne abusua a mmɔfra nkumaa ka won ho. Mpanimfoɔ a won nkoara nam DHS atenaee no ye beae wakeka abɔ mu. Mmusuakuo a mmɔfra ne apemfoɔ ka ho no nya won ankasa dan.

## **Gyidiekuo Atenaee Dwumadie**

Afie bi a wɔsom wo mu (a wɔsane nso fre no "gyidiekuo akwan") betumi awɔ mpa a esua sene 20 ma mpanimfoɔ wo baabi ara. Nnipa a yede won beko saa mmeae ahodoɔ yi betumi ako ho anwummerɛ nko ara na ne saa nti, ese se won pe baabi a won beko wo eda no mu.

## **Atenaee afoforɔ ben na ewo ho a enni New York Kuropɔn no mu?**

New York Kuropɔn no agye ahomegyebea dan agu ho a wode ma obi W'aba Foforo. Seesei, New York Kuropɔn no akyi mu no, mmusuakuo a mmɔfra nkumaa ka won ho ne mpanimfoɔ mmusuakuo no nya won ankasa dan ne adwarebea. Onipa onko nkoara nam no ne ofoforo kye dan baako. New York Kuropɔn no bema aduane ne ehyɛn a wo de beko Kuropɔn no mu akogyɛ ayarehwe ne atukotena ho nsem nhyehyee.

## **Na se me wo demdie bi na me hia mmoa soronko fa atenaee no ho nsoee?**

Obiara a orepere atenaee na wadi dem no wo ho kwan se obisa atenaee papa (reasonable accomodation) anaa "RA" RA ye nsesaee a aba wo nhyehyeee no mu na aboa ama obi a wadi dem no anya mmoa a won hia. Se wo hia RA baabi a wode wobeto se kotena ho a, ka kyere odwumayeni a owo w'atenaee ho no anaa dee owo Arrival Center no. Anaa, se wo wo DHS atenaee a, wobetumi ahyehye saa krataa yi [DHS RA Request Form](#). Atenaee ahodoɔ no mu bi, nkanka ne Respite Centers no, nnye papa mma nnipa a won adi dem bi, ne saa nti, eho behia se wo bisa pe RA ntam so bere a worepe atenaee no ara.

## **Nkrataa ben na mehia na me de anya RA?**

Se wo demdie no "da adi," ekyere se, nnipa tumi hunu dee wo hia a, wo nhia se wo de nkrataa biara ba ansa na wanya RA (bi te se, wo te akonwa a yepia mu). Se wo demdie no nna adi a, enee eho behia se wo dokota anaa onidefoɔ bi a ote wo demdie no ase di nkoma na oma wo nkrataa ahodoɔ bi. Dokota, neese, yarehwani anaa dokota biara a ohwe ayarefoɔ a owo nimdee fa wo demdie no ho no betumi ama wo nkrataa no. Esee se dee ohwe wo no twere krataa a eka se: 1) dee wo demdie no anaa nhwehwemu no tee; 2) atenaee a worepe; NE 3) dee nti a wo demdie no hia saa atenaee abisadee no. Esee se wo de w'abisadee no ne nkrataa edi adanse no ko atenaee anaa Arrival Center dwumayeni, na won beyi wo asotire afa won agyinasie no ho mmeretia bi mu eno akyi. Won betumi asere ne dee otweree wo krataa no adi nkoma bere a won wo nsemmissa bi fa w'ahiadee no ho no. Hunu pii fa RA nhyehyeee no ho wo DHS atenaee mu [wo ha](#).

## **Se obi a oye gay, lesbeen, dee otumi ne obaa anaa barima da, dee w'asesa aye obaa anaa barima anaa queer ("LGBTQ+"), metumi asere atenaee soronko? Akwanya ben na me wo NYC?**

Mmara si ho kwan se New York Kuropon no besi obi ho kwan se omma no atenaee enam se oye LGBTQ+ nti. Wo wo ho kwan se wo nya atenaee wo atenaee mmaee no mu a ene sedge wo si hunu wo bobeeasu tee no. Se wo ho nto wo wo w'atenaee ho enam se wo ye LGBTQ+ no nti a, wo ne odwumayeni a owo atenaee ho nkasa na kyere nneema ebema wo ho ato wo no mu kyere no.

Ewo HERRC a ewo Randall Island so no, Kuropon no akye apata no mu ama Won a w'asesa won Bobeeasu ne Nnipa Nnye Wo Bobeeasu nto mu Transgender and Gender Nonconforming ("TGNC") ahohoo. Saa beae yi ye baabi a y'aye ama obiara a ohunu ne se w'asesa ne bobeeasu, wonhunu wo se obaa anaa barima, anaa wobobeeasu tumi sesa. Seesei, TGNC kwan a eda ho no ye mpa 28 a ewo apata no mu a yakyekye mu. Saa TGNC kwan no wo banbo oforo wo ho nanso TGNC ahohoo no ko so ne nnipa afoforo a won ye ahohoo wo Randalls Island kye beae ahodoɔ bi te se baabi a yedidie.

Nnipa a won wo DHS panin a ono nkoara nam atenaee no betumi anya mpa a y'ahye da aye ama won a won ye LGBTQ+. Masrha House eye DHS atenaee a ewo Bronx a y'aye ama mpanimfoɔ a won ye LGBTQ+ nko ara. Ewo ho ma won a won adi mfee 18 kosi 30 na ewo mpa 81. Ahohoo a won awoberere bobeeasu ye lesbeen, gay, ne won a wotumi ne mmaa anaa mmarima

da no, wode won beko mmaa anaa mmarima atenaee se wontumi mfa won nko Marsha House a. DHS atenaee wo danpon mmaako mmaako wo ho ma TGNC ahohoo.

### **Na se me hia nyamesomkuo atenaee soronko bi nsoee?**

Etia mmara se atenaee dwumayeni bi behwe obi soronko enam ne gyidie anaa nyamesomkuo gyidie owo mu nti. Eduru mmerε bi a, Kuropon no betumi ama nyamesomkuo nnipa binom atenaee. Arrival Center no ne HERRC ahodoj pii no, se mfatoho, ma nnuane a nkramofoo ma ho kwan (halal nnuane). DHS, HPD ne NYCEM atenaee ahodoj no ma halal nnuane bere a obi bebisa. HERCC ahodoj no wo mmeae ahodoj a wode bo mpaee. Nanso, New York Kuropon no ntaa nnye adesre a obi de repε atenaee enam ne nyamesom gyidie so nti.

### **Na se me pe se me ka asem bi fa m'atenaee ho nsoee?**

Se wo wo HERRC, Respite Center, ahomegyebee anaa gyidie nyinasoo atenaee a, bisa dwumayeni a owo atenaee ho kwan a wobefa so abo w'amanee. HERRC ahodoj no mu bi wo amaneebo nkrataa.

### **Edeεn ne nna 30 ne nna 60 atenaee mmara no?**

Kuropon no taa ma nna 30 ne nna 60 nkaebo ma Won a W'aba Foforo wo atenaee ahodoj bi mu. Mpanimfoo a won nkoara nam ne mpanimfoo a abusuafoo ka won ho a W'aba Foforo no benya nna 30 anaa nna 60 nkaebo (se wo pe nsem pii fa nhyehyee no ho ne sdee wobanya nna no bi aka ho wo w'atenaee ho a, hwe: [ekwan a ede wo ko Nsem a Nnipa taa Bisa (FAQ)]. Mmusuakuo a mmofra ka won a wo te HERRC ahodoj mu no nya nna 60 nkaebo (se wo pe nsem pii fa nhyehyee no ho ne sdee wobanya nna no bi aka ho wo w'atenaee ho a, mia [ha](#)).

### **Nya Mmoa**
