On **June 25**, we will offer the live, online educational course, **Sexual Orientation, Gender Identity, & Expression (SOGIE) Training**, led by Erin Beth Harrist, Director, LGBTQ+ Law and Policy Unit.

1.5 hours/1 DEI + .5 Law Practice Management CLE credit

Our SOGIE training reviews how to create affirming work environments for LGBTQ+ colleagues and clients. Topics include *why an affirming environment matters, use of affirming language and terminology, obligations under New York City and State Human Rights Law, affirming practice checklist, and current issues impacting the LGBTQ+ community.*

This training is eligible for New York **Continuing Legal Education (CLE credit)** and is open to new and experienced attorneys. **Whether they are involved in the legal profession or not, this course will provide your team with an opportunity to increase their level of cultural humility around working with LGBTQ+ clients and colleagues.**
