

# **Report of the** Attorney-in-Chief **Executive Officer**

August began my third year as Attorney-in-Chief and CEO of The Legal Aid Society. While the previous twelve months had their challenges, I have been proud to lead such a committed team. I've never been more convinced that our work is necessary to address systemic inequities and blunt the devastating impact of poverty on the individuals, families, and communities we serve.

Though povertu has been on the rise in New York Citu since the end of pandemic-era financial support, its effects are dulled daily by the hundreds of legal matters handled by our Civil, Criminal, and Juvenile Rights Practices.

In Fiscal Year 2024, our clients contended with homelessness and evictions, the inhumanities of our carceral system, and the denial of economic justice for young people in foster care. We stood firm in the justice gap and fought for the low-income communities of New York.

Last uear, we showed the Citu that difficult moments aren't the time to abandon our values but rather when we should protect them.

In response to the influx of thousands of new arrivals to the five boroughs, the Adams Administration sought to water down the 43-year-old consent decree that guaranteed a right to shelter in the city - which would have inevitably led to widespread street homelessness. But this salvo was defeated in March, when we reached a settlement that keeps the consent decree intact, provides us additional oversight tools, and ensures that anyone needing a bed should have access to one.

After years of advocacy in Albany by Legal Aid, housing advocates, and tenants, lawmakers passed a budget in April that included Good Cause protections for tenants to defend against extortionate rent increases and unjust evictions. The final bill did not include everything we fought for, but it will make a meaningful difference for hundreds of thousands of renters statewide and keep New Yorkers housed in their communities.

We continued to hold the City accountable for failing to provide access to medical care and educational programming for incarcerated youth and for failing to fix decrepit jail facilities that compromise our clients' wellbeing. We maintain that the best way to meaningfully



address the morass that is our local jail system is for it to enter into federal receivership. Only an independent person, such as a receiver, not bound by local politics, can deliver the wholesale change all incarcerated New Yorkers need and are constitutionally entitled to receive.

Our Juvenile Rights Practice continues to fight for justice on behalf of disabled and orphaned children in foster care. We pushed, for example, the Administration for Children's Services to end its practice of steering Social Security Administration benefits away from children entitled to them, instead using the money to pay for agency costs. We are aggressively working to ensure that these children, some of our citu's most vulnerable, have full access to these life-altering funds to pay for vital needs and save for the future.

We also made significant gains toward my top priority: organizational funding fairness, which ensures our staff is adequately compensated and has the necessary resources to zealously represent the people we serve. Last year, we added staff, increased compensation, and modernized our technology.

The Legal Aid Societu is a bulwark for voiceless individuals. families, and communities, and improves society at large by empowering and uplifting those who need our help the most. The direct and systemic impacts we have on the lives of New Yorkers are immeasurable, and I continue to be honored and humbled to lead this storied institution.

# **Report of the Chair & President** of the Board

As we look to the future, our vision for a just New York is one where every individual, regardless of their background or circumstances, has the opportunity to thrive. We envision a city where systemic barriers are dismantled and the impacts of poverty are mitigated through access to equal justice.

We would not be able to realize this vision were it not for the support of our Sustaining Law Firms, individual, corporate. and private foundation donors, and Board of Directors. You are all equal partners in our efforts to serve as a stabilizing force in the communities we serve.

We also would like to give special recognition to philanthropist MacKenzie Scott, whose recent gift of \$8 million is a testament to the hard work of The Legal Aid Society's team of attorneys, paralegals, mitigation specialists, investigators, administrative staff, and interns. Together we are accomplishing vital work to decarcerate our communities, keep families together, and shield New Yorkers from homelessness.

At the same time, we are reminded of Martin Luther King Jr.'s observation that change does not roll in on the wheels of inevitability, but rather comes through continuous struggle. And so, as we look towards a better tomorrow for low-income New Yorkers, the nearly 2,300 heroes we call our staff continue to rise to the challenges that present themselves to our clients on a daily basis.

There are many important accomplishments and victories The Legal Aid Society can claim from the last year.

We ensured that New York City's legacy as a safe haven where all are guaranteed a roof over their heads, regardless of where they came from, was preserved. In the wake of the arrival of tens of thousands of new arrivals seeking refuge in the city, the Adams Administration had threatened to do away with the consent decree that established the city's right to shelter in 1981. But, working with allies, we reached a settlement with the Administration that preserves this fundamental liberty. And, after years of our advocacy, Governor Hochul finally signed into law a Good Cause measure that, while not what we originally envisioned, nonetheless provides historic protections against unjust evictions and unreasonable rent increases for New York City tenants.



We maintained our fight to protect those jailed in the state's jails and prisons - especially the most vulnerable, such as those with disabilities or those persecuted for their gender identities. We continued to pressure the court presiding over our litigation against the ongoing inhumane treatment at Rikers Island and other jails to appoint a federal receiver to take over the system from the Department of Correction, we sued the state for its illegal practice of placing people with disabilities in solitary confinement, and we asked a federal court to hold DOC in contempt for failing to ensure incarcerated people receive proper medical care.

We also looked after the City's population perhaps most susceptible to harm - youth involved in the child welfare, juvenile, and criminal legal systems. We drew public attention to, for example, the Administration for Children's Services' abhorrent practice of pocketing for itself Social Security Administration benefits intended to pay for the everyday needs and future expenses of children in the foster care system.

Frederick Douglass famously observed that "Power concedes nothing without a demand." For nearly 150 years, The Legal Aid Society has demanded justice and equity on behalf of the powerless of New York City. With your support, we will continue this important work.

# **Outstanding Pro Bono Assistance to the** LGBTQ+ Unit

This was a challengin case, but the team remained dedicated to fightin against a practice that has historically been difficu to litigate and ultimately achieved a stellar result for the client.

### **Mayer Brown**

The LGBTQ+ Law and Policy Unit and Prisoners' Rights Project nominate Mayer Brown for their amazing work in preparing a case against the New York State prison system for refusing to transfer a transgender woman to a women's prison, despite the clear risks to her safety and well-being. After diligent research and advocacy, the Department of Corrections and Community Supervision (DOCCS) agreed to move the client. The firm's work is a part of the effort to change DOCCS' transphobic approach to housing decisions.

Fried Frank has been a crucial partner to the LGBTQ+ Law and Policy Unit in the success of the monthly Ali Forney Center Transgender Name Change Clinic. The partnership has been a fantastic way to bring needed resources to an underserved group of people, LGBTQ homeless youth.

Fried Frank has also been an important partner in representing Legal Aid in a pending FOIL before the NYC Department of Correction with the goal of increased information about the treatment of TGNCNBI people in custody.

## **Freshfields**

In partnership with the Criminal Appeals Bureau and the LGBTQ+ Law and Policy Unit, Freshfields cocounseled a motion to resentence a gender-expansive person under the Domestic Violence Survivors Justice Act. This case presents an important opportunity to ensure state courts equitably apply this important law to LGBTQ+ community members who experience intimate partner violence.

# Tireless Pro Bono Advocacy Securing Vacatur of a Wrongful Conviction

## Garrett Ordower Scale

Garrett worked for a decade with the Criminal Appeals Bureau to help secure the exoneration of wrongfully convicted client Steven Ruffin. He worked doggedly to reinvestigate the case and convince the Brooklyn District Attorney's office that Mr. Ruffin was innocent. In January 2024, Mr. Ruffin was exonerated.



# Outstanding Pro Bono Assistance to the Employment Law Unit

### Cravath

The Cravath, Swaine & Moore team assisted Legal Aid's Employment Law Unit in litigating a wage and hour, discrimination, and tenant harassment case against one of New York City's worst landlords (as designated by the Public Advocate). Our clients were a superintendent and his domestic partner. The firm's deposition practice and completion of discovery were invaluable in reaching a settlement that the clients can use to secure stable housing.

## Wang Hecker

The Wang Hecker team led the litigation through the early stages of discovery, gathered and reviewed documents from the client, and analyzed the defendant's document production. They successfully encouraged defense counsel to agree to mediation before a magistrate judge, which led to a favorable settlement for the client.

### Petrillo Klein + Boxer

The Petrillo Klein + Boxer team helped prepare our client and conduct numerous depositions in a short time and with a constantly changing schedule. They reviewed discovery and helped us press for missing responsive material. The depositions resulted in helpful fact discovery that contributed to our ability to settle the case.

## **Schlam Stone**






# The New York **Community Trust** Foundation

The New York Community Trust celebrates its centennial this year. It was formed in 1924 by 11 trustee banks and, seven years later, created the nation's first donor-advised fund. Since its founding, the Trust has awarded more than \$5.7 billion in grants to nonprofits across New York City, Long Island, Westchester, and beyond. It awarded its first gift to The Legal Aid Society in 1982.

"For decades, The Trust has been a supporter of defending New Yorkers' civil liberties and protecting their hard-earned rights. The Legal Aid Society has been a lead partner in these efforts," says Chantella Mitchell, a program officer with The Trust. Over those 40 years and counting, The Trust has provided millions in funding to underwrite Legal Aid's litigation and advocacy to assist new immigrants to New York City, young people in foster care, incarcerated people, and families experiencing homelessness.

As New York's largest community foundation, The Trust's mission is to foster and engage in enduring and innovative philanthropy. It does so by connecting generous New Yorkers with effective nonprofits, and collaborating with foundation colleagues, community organizers, and local governments to identify ways to support diverse communities in New York City, Long Island, and Westchester. Hundreds of donors have created permanent funds at The Trust, often dedicating them to specific causes, places, communities, or organizations.

As The Trust surveyed the post-pandemic landscape in New York a few years ago, it became increasingly



concerned about the city's deepening affordable housing and homelessness crisis. Rents had climbed back to their pre-pandemic levels and homelessness was the highest in the city since the Great Depression, having a disproportionate impact on communities of color already struggling with housing insecurity.


The Trust responded by awarding millions in grants to nonprofits helping to protect the affordability of existing housing, and to ensure that low-income New Yorkers, including homeless residents with complex needs, were able to access this housing.

The Trust recently funded The Legal Aid Society to ensure rental assistance is more widely available to New York City families who need it, and that once received, families don't have to jump through bureaucratic hoops and face housing discrimination before they can move into their new homes. This effort is designed to strengthen the City's housing voucher program and streamline the process to move families into affordable homes.

The Trust expects to build on its affordable housing work. "We hope to continue to support the many strategies and programs we know are successful in getting and keeping people safely housed," says Mitchell. These include supporting rental assistance, advocacy for supportive houses and wraparound services, protecting families from eviction and displacement, and advocacy for new programs and housing supports that are responsive to the current affordability needs in New York City today.

The approach speaks to Goldman Sachs' durable partnership model and the performance tracking it has implemented across its portfolio of community engagement initiatives.

Goldman Sachs' desire to strengthen the communities it operates in led it to launch, in 2009, the Community Development Grants program, which supports organizations that are addressing critical community needs, including affordable housing, small business development, community support services, and neighborhood revitalization. - which provides direct representation and advice to consumer clients facing a wide variety of issues, including credit card debt, business disputes, landlord/ tenant issues, and property damage and theft - as a linchpin for the low-income New York City community.

Goldman Sachs views its commitments to date as only the beginning, and it is evolving its giving in response to what it is hearing from its charity partners. After meeting with more than 50 nonprofits in 2023 who expressed an urgent need for trust-based, multiyear, general operating support, the company launched this year the Equity Builders Initiative, which will award millions in unrestricted funding to grantees. #### **Denis McInerney**

Denis McInerney has worn a lot of hats in his nearly 40-year career as a private and public sector attorney. Assistant U.S. Attorney in the Southern District of New York. Associate Counsel in the Whitewater investigation of the 1990s. Partner and now Senior Counsel at Davis Polk where, among others, his clients included Arthur Andersen during its criminal trial in the early 2000s.

But "without question," he says, "the most meaningful and rewarding cases I have ever worked on" are the pro bono Domestic Violence Survivors Justice Act (DVSJA) ones he's partnered on with The Legal Aid Society's Criminal Appeals Bureau (CAB) over the last five years.

McInerney has been passionate about aiding trafficking victims since he joined the board of Sanctuary for Families in 2005. But he had never done pro bono work when, shortly after enactment of DVSJA in New York State in 2019, longtime CAB attorney David Crow approached McInerney and his Davis Polk colleague Dara Scheinfeld about assisting Legal Aid in reducing the sentences of incarcerated domestic violence and sex trafficking survivors. "I could not have done any of it without David or without Dara," says McInerney, "and none of this would have happened had David not spearheaded our efforts starting in 2019."

It wasn't hard to convince other Davis Polk associates to contribute to the thousands of hours the firm has dedicated to domestic violence and trafficking cases. "It doesn't get any better than knowing your client is coming out of prison because of the work you put into it," says McInerney.

The 17 victories the Davis Polk team has recorded in partnership with Legal Aid and others include a

ly domestic violence survivor who graduated from college while in prison and is now earning her master's in social work, a young woman who was forced to take part in robberies by the gang that trafficked her as a teenager, and, in September of this year, another teenage sex trafficking victim had over 15 years wiped out from her original sentence, resulting in her walking out of prison the next day. McInerney says the trauma-informed approach and cooperation of the Manhattan District Attorney's Office was "indispensable" in this case.

McInerney has been a donor to Legal Aid since 1987, but he admits his giving has been going up in the five years he's worked with Crow. He's now a member of the Justice Network, and when he was approached in 2021 about joining the Associates' Campaign, he came up with the novel idea of linking Davis Polk's fundraising efforts to an employee health and wellness program. That resulted in Davis Polk, with a total of \$77,000, climbing to the top of the Associates' Campaign ranks this year.

McInerney hopes his goodwill inspires others to give. "Whatever I can do to not only personally contribute, but to try to get Legal Aid on the radar for other people, and get people to see how valuable they are," he says.

# Jeffrey Glen and **Rosina Abramson**

Attorneys Jeffrey Glen and Rosina Abramson have been married for 47 years, and one of many constants for them over the decades has been their connection to The Legal Aid Society.

They met in the early 1970s, when Rosina ran a Legal Aid clinic program for law students and Jeffrey headed up the Harlem Community Law Office. He had arrived at Legal Aid from Mobilization for Youth, an anti-poverty program based in Manhattan, and they shared a passion for social justice. In Harlem, Jeffrey developed with students from Columbia Law School a civil legal program that represented lowincome people who faced having their possessions seized or utilities cut off.

Their financial support of Legal Aid grew out of this latter stage of their careers. 


