

If the police come to your door, you don't have to let them in unless they have a warrant signed by a judge!*

ASK THEM TO SLIDE THE WARRANT UNDER THE DOOR:

"Please, officer, I want to see the warrant. Please put it under the door so I can read it."

* A removal order signed by an immigration judge is not a warrant and does not give officers permission to enter your home.



A COURT WARRANT IS:

1. Issued by a court (look for the name of the court on top)
2. Signed by a judge (it says "judge" or "justice" below the signature line)



AN ICE WARRANT IS:

1. Issued by the Department of Homeland Security rather than a court
2. Signed by an immigration officer

You are therefore commanded, anytime, to make an immediate search of East 00 Street, Apartment 00, Brooklyn, New York.

The subject location 000 East 00 Street (the "building") is a multi-family home located between Avenue 0, Brooklyn, New York, 000 East 00 Street, and East 00 Street, Brooklyn, New York. The subject location is the Basement Apartment which is accessed through the shared driveway. To access the subject location from the street, one walks through the shared driveway, enters through a metal gated door into the building. The subject location is the basement apartment located through the door on the right side of the door to the target apartment.

And you are directed to return this warrant, and deliver any property seized pursuant thereto, or an inventory thereof, without unnecessary delay, before any judge or justice in Kings County Criminal Court, 000 Street, Brooklyn, New York.

"I do not consent to a search of my home. Please do not come inside."



IF THE POLICE OR IMMIGRATION OFFICERS ENTER YOUR HOME, YOU SHOULD NOT RESIST. BUT YOU HAVE THE RIGHT TO REMAIN SILENT IF THEY ASK ANY QUESTIONS.
